State police is continuing investigation at hospital

Investigation into the financial records at Saline Memorial Hospital is still under way, Prosecuting Attorney Bob Alsobrook said today.

Alsobrook said he conferred Wednesday with State Police Investigator Dale Swesey and was told that the investigation is not expected to be completed forthree or four more days.

Also participating in the investigation is Frank Mitchell of in the case and for a special the State Police.

That probe officially began at 1 p.m. March 7, two days after Saline Memorial Hospital Board members voted in a special session to accept the resignation of Hospital Adminstrator E.F. Black Jr.

Hospital officials have not stated any reasons for Black's

resignation and the board chairman, Dr. Jim Porter, has said that any additional information about the situation would have to come from Alsorook's office.

Local hospital board accepts resignation of Black

Saline Memorial Hospital Board, meeting in a surprise special session Monday night, voted unanimously to accept the resignation of Hospital Administrator E.F. Black Jr.

Black did not attend the meeting and no explanation of his resignation was offered by members of the board.

The board named Tommy Gilbert, one of the hospital's two associate administrators, to serve as the interim administrator until a new administrator is chosen.

This action took place in a brief public session that followed a 50-mintue executive session.

When the open meeting began, Dr. Jim Porter, board chairman, announced that he would entertain a motion. Board member Mary Frances Izard presented the motion to accept Black's resignation and board member Robert Haynes seconded the motion.

A unanimous vote sealed that-

act, which was followed by a motion from board member Jim Villines to name Gilbert as interim administrator. Board member James Curtis seconded the Villines motion, which also passed unanimously.

The session then adjourned.

After the session had adjourned, Dr. Porter told reporters he could not, at this time, release any other information related to Black's resignation and, when contacted today at the hospital, did not offer any additional explanation.

Board member Jim Villines had "no comment" when reached today and efforts to contact other board members were not successful. Attempts to reach Black at his home were also unsuccessful.

Black, who has been administrator of Saline Memorial since 1976, joined the hospital as assistant administrator in July 1974. Even though he did not become the official administrator of the facility until after the death on Nov. 19, 1976, of Art Wilson, the hospital's chief executive for 18

years, for several months prior to that time, Black had assumed many of Wilson's duties when failing health made it impossible for Wilson to perform those functions. In an October meeting of that year, the hospital board had already voted to make Black administrator, effective Dec. 1, 1976.

Black, a Benton native and a 1962 graduate of Benton High School, attended Ouchita Baptist University and Henderson State University. He is married to the former Linda Butler, and they have two children, Robert and Patrica. His parents are Mr. and Mrs. E.F. Black Sr. of Benton.

Prior to accepting the position of assistant administrator at Saline Menorial, Black was director of the admitting and business office at St. Mary Medical Center, Bauer Hospital, in Long Beach, Calif.

He also was employed in various departments of St. Joseph Hospital in Houston, Texas, and from 1966-1969, owned and operated a collection agency.

Grand jury needed

More than a week has passed now and nothing new has surfaced regarding the mysterious resignation of E. F. Black Jr. as administrator of Saline Memorial Hospital.

Rumor and innuendo abound, however.

After a couple of days of hide and seek with the board it became official that nothing more would be forthcoming, except through the prosecutor's office. The prosecutor's office, eaded by Bob Alsobrook, made a statement that the state police would be conducting an investigation. He said no further information would be forthcoming until that investigation was completed.

The deputy prosecutor, Dan Moudy, is Alsobrook's law partner. Moudy also serves as attorney for Saline Memorial Hospital. He was involved in advising the board regarding the resig-

nation of Black

Both Alsobrook and Moudy are highly respected in their profession.

Through the fault of neither, a conflict of interest has been created by the situation. There is but one way to overcome this conflict and serve the public's interest.

Mr. Alsobrook must step aside.

The state police should continue its investigation, but should turn over all its evidence to a special prosecutor, who should be appointed immediately.

Further, a grand jury should be called by a special prose-

cutor without hesitation or delay.

Saline Memorial Hospital has been, and will continue to be, a fine institution. It has served Saline County well. It will continue to serve her well.

But it cannot stand the rumor and innuendo that has sur-

rounded it and its former administrator.

It is a county hospital. The residents of Saline County have a right to know if any wrongdoing has been committed. It is only proper that the full story should surface.

The haste with which a decision is made is as important as

whether it is made.

Hospital board chairman calls press meeting

Dr. Jim Porter, chairman of Saline Memorial Hospital Board, revealed in a press conference today that the sudden resignation of Hospital Administrator E.F. Black Jr. on March 5 resulted from "personal problems which had apparently impaired his management capabilities."

Porter said Black's decision to resign followed a review of hospital financial records on March 3. At that time, Porter said the board was made

aware of "some financial discrepancies that internal fiscal con-

trols could not validate."

He said the board attorney was consulted and on March 4, the prosecuting attorney was notified that the records in question were being reviewed and would be submitted for his verification.

On March 5, in a meeting with the controller, outside auditor and the administrator, a review was made of the records in question, and following that session, the administrator decided it was in the best interest of the hospital for him to resign, Porter said. That resignation was officially accepted later in the day at a called session of the hospital board.

Porter said Black had requested and received care as recommended by an area physician not associated with the board. He had served. slightly more than one year of a three-year contract at that time, he added. Black had been administrator

at the hospital since 1976.

Porter assured the media that "the hospital is solvent and is running in normal fashion. The board is satisfied

that the highest standard of patient care continues to be provided."

Porter said the board did not issue any statements at that point "since the prosecuting attorney's office was to verify the records" and the board was awaiting the outcome of that report before making any comments.

He said that late Tuesday, March 6, it was learned that the prosecuting attorney felt an objective investigation by an outside agency should be undertaken, which had begun by noon on March 7.

"Based on the original items in question, the board felt that a prompt investigation could be done, the facts made public and the matter resolved as quickly as possible by whatever means necessary," Porter said. "Obviously, the situation has required

more extensive investigation than originally anticipated."

He emphasized that there was no delay in turning the investigation over to the property authorities.

"We are as anxious to resolve this issue as anyone," he said. "We agree that the public has every right to know what is happening at the hospital."

However, Porter said the board does not feel that haste should interfere with "accurate fact-finding or the rights of any individual."

He said he believes the record will show that "everyone at the hospital has cooperated with the authorities in this matter and that the board and its counsel have recognized their obligation to both the public and the individual."

Prosecutors sometimes use grand cover additional information for use in crimminal cases. An indictment is handed down when grand jurors are persuaded by the evidence that the prosecutor has reason to try a case.

Those under investigation by a grand jury may be called to testify but are not allowed to use an attorney to present rebuttal evidence. That opportunity comes later when anyone indicted is tried before a 12-member petit jury.

If the grand jury indicts a suspect, the prosecutor usually believes he will have an easier time of winning in the actual trial. Even if no indictment is returned, however, the prosecutor sill has the option to try the case before a petit jury.

Black resigned from the hospital' March 5 and had served one year of a three-year contract at that time.



In a split decision, Saline Memorial Hospital Board voted 4-2 today to pay \$23,027.05, including retirement benefits, to the hospital's former administrator, E.F. Black Jr., as settlement of his contract.

That figure is the gross amount of the settlement, board chairman Dr. Jim Porter said. The actual figure will be minus federal, state and Social Security deductions, he said.

Black resigned his position as administrator March 5 after financial discrepancies had been discovered at the hospital.

The money to settle Black's threeyear contract, of which he had served one year, is to be placed into an escrow account that Black will not have access to until it is determined if he will be convicted of criminal charges.

Black is charged with 20 counts of theft of property and was one of three persons indicted Thursday by a Saline County grand jury.

A contribution on behalf of Black was made by the hospital to the Safeco Tax Sheltered Annuity Retirement Plan for Saline Memorial Hospital employees at the rate of 10 percent of

All meals at the hospital were provided for Black at the hospital's expense.

Black was given a non-receipted expense account of \$200 monthly.

In addition to other standard contract provisions, paragraph seven of Black's contract said, "The hospital reserves the right to terminate this agreement in the event that E.F.

Grand jury indicts E.F., Linda Black

Saline County Sheriff James Steed today released the names of the two other persons who were indicted last week by a Saline County grand jury. Indicted were E.F. Black Jr., former administrator of Saline Memorial Hospital, and Black's wife, Linda.

The sheriff's office announced Friday that Jim Ralph, the director of purchasing at the hospital, who had been suspended during a State Police investigaion, had been indicted, along with two other persons.

The names of the other two were not released, pending the serving of arrest warrants. Steed said those warrants are being served today.

Bond has been been set at \$25,000 for E.F. Black and \$2,000 for Linda Black. The amount of bond was set

by Judge John Cole Thursday at the conclusion of the grand jury proceedings, the sheriff said.

Ralph entered a plea of not guilty in arraignment proceedings today and was released on a \$18,750 bond.

Steed said that E.F. Black and Linda Black are scheduled for booking Wednesday.

Black's resignation as administrator came about March 5 in a called session of the Saline Memorial Hospital board and a State Police investigation into financial discrepancies at the hospital began two days later.

Delbert Mickel Jr. of Little Rock is serving as the attorney for the Blacks and Pete Lancaster and Curtis Rickard are representing Ralph.

Hearing set for Thursday

The former administrator of Saline Memorial Hospital and his wife are to be arraigned in Saline County Circuit Court Thursday, Prosecuting Attorney Bob Alsobrook said today.

E.F. Black Jr. is charged with 20 counts of theft of property, and his wife, Linda, is charged with one count of theft of property.

That hearing is tentatively set for 9 a.m. before Judge John Cole, Alsobrook said.

Indictments against E.F.
Black and Linda Black were
handed down last Thursday by
a Saline County grand jury that
also indicted Jim Ralph, director of purchasing at the hospital.

Black resigned as administrator of the hospital March 5, and Ralph was suspended during the course of a State Police investigation of financial discrepancies at the hospital.

Trials for the three persons are expected to be set for July or August, Alsobrook said.

He also said that the total estimated value of the stolen property involved in the three indictments was estimated between \$10,000 and \$15,000. He did not specify what the stolen items were, but said that no narcotics were involved.

Bond has been set at \$25,000 for E.F. Black, \$18,750 for Ralph and \$2,000 for Linda Black.

The entire predicament involving Saline Memorial Hospital and its former administrator has been an embarrassment to the Hospital Board of Directors.

The board is the governing body of the county entity and has the final say in the major decision-making process. But, no one believes the board is totally responsible for recent problems -

at least no one should.

The board truly has been swift in its actions, delayed only by a State Police investigation that took longer than most had anticipated. One failure of the board, however, was not keeping the public updated on the "goings on" at the hospital following the sudden resignation of E.F. Black Jr., the former administrator.

Dr. Jim Porter did, however, call a press conference near the end of the investigation to update the public. The information gleaned from that forum was sparse, but it was all of the available information the board could provide at that time. Porter is

chairman of the board.

The board-likely-will-come-under-some criticism for its Monday decision to settle the contract of Black. While Black's contract was likely more lucrative than it should have been relating to the administrator's expenses and the apparent rubber stamping of those expenses by the board, the decision to settle the contract and place the \$23,027.05 into an escrow account is the best decision the board could make.

The biggest problem facing Saline Memorial Hospital at this juncture is getting the entire operation of the hospital off the rocky road it has been traveling and onto a smoother surface. That can only be accomplished by seeking out a new administrator with a proven record to come in and run the hospital in a

manner becoming to Saline County.

The board could not begin that search until Black was out of the picture. As the special attorney for the board explained, the only way to get Black out of the picture was to settle his contract.

If Black is convicted of a felony offense, however, he is not -entitled-to-any-of-the-hospital's-money, according to his-con-

tract.

The board's selection of a new administrator should not only be speedy, but it also should be a decision that the board, the employees of the hospital, and the people of Saline County will be proud of for many years to come.

The board must now wipe that egg from its collective face and get on with the duties at hand. We have no doubt they will

do just that.

Ralph suspension subject of meeting

Saline Memorial Hospital Board will be meeting in a special session at 7 tonight to deal with a personnel matter related to a suspended employee, Jim Ralph.

Ralph, the hospital's director ofpurchasing, was one of three persons indicted last week by a Saline County grand jury that had been called to investigate financial discrepancies that were discovered at the hospital.

Ralph has been charged with 15 counts of theft of property. The board has not terminated him from the hospital, but is expected to make a decision regarding his position at tonight's meeting.

The board has been concerned with some complex personnel problems during the past few weeks, beginning with the March 5 resignation of the hospital's administrator, E.F. Black Jr.

During a State Police investigation that began two days after Black's resignation, Ralph was suspended at the request of investigators.

A grand jury that was called todeal with matters pertaining to that investigation handed down indictments against Ralph, Black, and Black's wife, Linda.

Meeting in a special session at noon Monday, the board agreed to a negotiated settlement of Black's three-year contract. His resignation occurred after he had served one year of a three-year contract.

Board members differed in their feelings about a financial settlement, but in a 4-2 vote, the board approved a negotiated settlement which calls for paying Black \$23,027.05, plus retirement benefits. The board also extended his hospital benefits for six months.

The figure named in the settlement is the gross figure and does not take into account federal, state and Social Security deductions. It represents one month's severance pay, which is customary, plus one-third of the remainder of this year's wages, board chairman Dr. Jim Porter said.

Any moneys in question in the indictment will be held in an escrow account, pending the results of criminal proceedings involving Black, who is charged with 20 counts of theft of property. The hospital board has not been told the exact amount of money that is involved in the charges against Black.

In Monday's meeting, attorney Buddy Sutton of the law firm of Friday, Eldridge and Clark presented his recommendation to the board.

Benton residents E.F. Black Jr. and his wife, Linda, entered not guilty pleas in arraignment proceedings today in Saline County Circuit Court.

Circuit Judge John Cole set July 19 and 20 as dates for the couple's trial.

Black, 39, is charged with 20 counts of theft of property; Linda Black, 36, is charged with one count of theft of property. Both were indicted last Thursday by a Saline County grand

jury.

Prior to today's hearing, bond had been set at \$25,000 for E.F. Black and \$2,000 for Linda Black. counts of theft of property; Linda black with one count of theft of proporty of Sacrety; and Ralph with 15 counts of theft of property. All entered not guilty pleas during arraignment proceedings last week. Bond has been set dminis at \$25,000 for E.F. Black, \$2,000 for ad Jim Linda Black and \$18,750 for Ralph.

Trial dates are July 19 and 20 for E.F. and Linda Black; no trial date has been set for Ralph. Hart's trial will not be scheduled until after she has been arraigned.

The State Police investigation at the hospital began March 7, two days after Black resigned. Investigator Dale Swesey said last week that the investigation had not concluded and that additional arrests in connection with that probe were a possibility.

Saline Memorial Hospital Board will be meeting in a special session at 7 p.m. Thursday to review the hospital's personnel and administrative policies. The board also will discuss a time frame for taking applications and conducting interviews for the administrator's position.

Bank lawsuit names Black

Benton State Bank has filed a lawsuit to foreclose a mortgage on property owned by the former Saline Memorial Hospital administrator, E.F. Black Jr., and his wife, Linda.

The litigation concerns the couple's home at Lake Norrell.

Also named as defendants are Benton Savings and Loan Association and First American National Bank.

The suit is the second within the past week to be brought against the couple by a local financial institution. Last week, Union Bank of Benton filed a similar suit regarding property the Blacks own off Lyledale Road.

Benton State Bank's suit states that on Feb. 9 of this year the Blacks executed a promissory note in the amount of \$42.769.56, bearing interest from its date at the rate of 13.5 percent per annum and payable on demand or, if no demand, then in monthly installments of \$789.74 each until paid in full.

That promissory note is secured by two realty mortgages, the suit states. Both are recorded in the Saline County Circuit Clerk's Office in the county courthouse; the first of the mortgages

was recorded Oct. 29, 1982, the suit states.

The Blacks have defaulted in the payment of the indebtedness secured by the mortgages, despite demands that have been made for payment, the suit says. The principal sum of \$42,769.56 is now due, plus accrued interest, as of April 4, 1984, of \$870.03. This interest will continue to accrue daily at the rate of \$15.81 until paid.

Benton Savings and Loan Association may be claiming some interest in the Lake Norrell property by virtue of a realty mortgage executed by the Blacks on May 22, 1981, and filed May 26, 1981, in the circuit clerk's office, the suit says.

The plaintiff says that First American National Bank may also claim some interest in the property because the plaintiff has reason to believe that the Blacks also executed and delivered a realty mortage to that institution.

Ted Boswell of Bryant is representing Benton State Bank in the lawsuit.

Union Bank's suit asks for a judgment of \$2,988.05 from the Blacks and

also seeks an injunction preventing members of Saline Memorial Hospital board from disbursing or depleting funds placed in escrow as a contract settlement with Black.

Greg Brown is the attorney for Union Bank.

Black resigned his position as hospital administrator. March 5 after serving one year of a three-year contract. Two days later, a State Police investigation into financial discrepancies at the hospital began.

Information uncovered in that probe led to the calling of a county grand jury that handed down indictments for E.F. Black, Linda Black and Jim Ralph, the hospital's former director of purchasing.

The three were charged with theft of property. E.F. Black is charged with 20 counts, Ralph with 15 counts and Linda Black with one count. All have entered not guilty pleas in Saline County Circuit Court.

A fourth person was arrested this week in connection with that State Police investigation. Carla Hart, the hospital's former director of medical

records, was arrested Tuesday and is charged with one count of theft of property involving the alleged falsification of a \$754 travel expense vou-

cher for the hospital.

E.F. and Linda Black's trials have been scheduled for July 19 and 20. No date has been set for Ralph's trial. Hart is scheduled to enter a plea at arraignment, proceedings May 7; a date for her trial is likely to be set at that time.

Bond is set at \$25,000 for E.F. Black; \$18,750 for Ralph; \$2,000 for Linda Black; and \$1,000 for Hart. All were released after being processed at the Saline County Detention Facility. The hospital board, which has met often since the hospital's financial irregularities were discovered, will be meeting again tonight.

That session, which will begin at 7 p.m., will concern a review of the hospital's personnel and administrative policies. The board also plans to discuss a time frame for taking applications for a new administrator and for conducting interviews with applicants for the job.

Search to begin for administrator

Saline Memorial Hospital Board, meeting Thursday night in a special session, formally approved the resignation of Carla Hart, who has been the hospital's director of medical records, and officially began the search for a new administrator at the local medical facility.

Hart was arrested Tuesday on a theft of property charge that allegedly involves the falsification of a \$754 travel expense voucher. She is tentatively scheduled for arraignment on May 7.

When Hart submitted her resignation to hospital, May 3 had originally been its effective date. However, that time frame was altered following her arrest

Dr. Jim Porter, board chairman, told the board of the need to announce in major publications that the hospital has an opening for an administrator. The hospital's former administrator, E.F. Black Jr., resigned March 5 and has since been charged with 20 counts of theft of property. He was one of three persons indicted by

a Saline County grand jury that had been called to hear evidence uncovered during a State Police investigation of financial discrepancies at the hospital. The other indictments were for Black's wife, Linda, and Jim

Ralph, the hospital's former director of purchasing.

The board unanimously voted to authorize the acting administrator, Tommy Gilbert, to prepare the advertising notices regarding the administrator's job. The deadline for submitting these would determine the time frame for taking applications and scheduling interviews with potential applicants, Porter noted, but it was agreed that this could be done by June 1.

In an unrelated matter, the board unanimously voted to purchase two ambulances from Summers Ambulance and Coach Sales, a firm located in Duncanville, Texas, for a total cost of \$52,330. Those ambulances, which will be used in a new ambulance service the hospital is implementing, are expected to be delivered to the hospital within a few days.

The board also agreed to purchase ambulance radio equipment at a cost of \$1,1908 from Motorola Communications and Electronics Inc. of Little Rock.

Both of these items had been discussed at prior meetings.

In addition, the board approved the purchase of replacement diagnostic equipment for the emergency room at a cost of \$8,300.
